

# **Cherish Chilbolton**

# Who we are, what we're doing, how you can help

We're a group of villagers who've come together to raise awareness amongst the community of James Painter's planning application for 75 houses on farmland he owns in Chilbolton. We love our village and fear what the scale of this development would do to our small rural community and quality of life. We say No to this proposed over-development of our cherished village. The site is close to the Conservation Area and conflicts with both the Neighbourhood Development Plan, which the community worked so hard on, and the Village Design Statement.

Quite simply, the scale of development planned outside the settlement boundary is not needed, justified or sustainable; particularly in terms of the huge increase in traffic that would be generated through our narrow village lanes with few pavements and on access roads including Station Road, Branksome Avenue and Drove Road; the demands on services and infrastructure already at capacity; and the damage to the natural environment (the list goes on). We fear too that this is just the beginning, with further development on a similar scale likely in the next field, threatening the historic heart of our village and causing irreversible harm to the Cow Common, River Test and wider biodiversity, as well as village life as we know and love it.

Cherish Chilbolton is here to support as many members of the community as possible to have their say and respond to Test Valley Borough Council with their feedback on the planning application, ideally by 12<sup>th</sup> December 2025; we understand comments can now be made up until 12<sup>th</sup> January 2026, which is the Parish Council's deadline to respond, but encourage residents to have their say pre-Christmas! Remember every person in the household can comment and individuals can send multiple objections (sending your comments by email doesn't restrict word limit and you can attach supporting photos e.g. of congestion).
